Description of the SMC

Facility

Capacity: 313 seats¹⁾

3 extra seats for disabled persons in wheelchairs

Stage

Surface area: 80 sq. m

Dimensions (length x width): 10.5 m x 12 m

Technical equipment: basic equipment

Grand Foyer

Surface area: 2,700 sq. m

Catering: cf. terms and conditions governing catering service organisation.

Renting fee²⁾

Price for concert: 2.131 €³⁾⁴⁾⁵⁾ (max. 7 hours of use)

Price for conference and/or amplified concert: 2.878 €³⁾⁴⁾⁵⁾ (max. 10 hours of use).

The renting fee includes

- Use of the SMC and the pertaining back-stage area. All activity in the SMC and in the back-stage area must be finished by 11:00 pm. To keep to this schedule, we suggest ending any concert/event by 10:30 pm at latest.
- 1 stage manager. Stage handling work, including basic lighting, must be managed by the Public Establishment.
- 1 Public Establishment representative.
- Standard cleaning service.

For any additional staff, infrastructure, furniture, and technical equipment requirements, please contact the Public Establishment's Events team.

Mandatory Services²⁾

- Min. 4 people provided by the Public Establishment to assist visitors and 1 person for the cloakroom:
 - 34 €/pers/hour (business days)
 - 60 €/pers/hour (Sundays)
 - 67 €/pers/hour (national holidays)

The number of people and the duration of the visitor support service vary with the type of event and the audience size. They are at the discretion of the Public Establishment.

The Public Establishment reserves the right to change its rental prices and terms and conditions at any given time.

1) The Public Establishment reserves the right to use 2 seats per concert/event for internal purposes (to be deducted from the capacity indicated).

2) All prices indicated in this document exclude VAT. The VAT rate in force shall be added to the final invoice.

3) Reductions to be determined by the Public Establishment based on the type of event.

4) 20% reduction on the Grand Foyer if also hired.

5) Price for a second same-day performance on request.
